**38/24 Apologies** were received from Cllrs. Peter Clarke, Brian Rendell and Tom Grindey (reasons accepted and noted)

#### 39/24 Minutes

Resolved that the minutes of the meeting held on 27 March 2024 be confirmed as a true record and be signed by the Chair

#### 43/24 Ongoing Items

- Extension of 50mph limit to Levens Bridge: The Clerk had written regarding the request to amend the proposal to 40mph throughout but had not yet received a reply
- Proposed village 20mph zone: W&F Cllr. Battye stated that she understood that the Heversham proposal was not
  on the list that was recommended to go forward in the first tranche but that the final decision had yet to be
  finalised by the Locality Board. If not on this year's list, it would be considered for the second tranche next year.
  Cllrs. had responded to the proposed action regarding responses and comments received during the consultation
  with parishioners and the Clerk was asked to discuss this with Cllr. Clarke on his return from holiday so that the
  agreed action could be pursued
- Crow Wood and yellow line parking restrictions: No reply had been received from W&FC regarding clarification of the ownership of the area used for parking
- Field of Dreams: A reply to the Council's claim was still awaited

- a. Westmorland & Furness Cllr. Battye reminded Cllrs. that the Bus Service Improvement Plan consultation was to end on 30 April and informed the meeting that EV charging points were to be increased in the Council area
- b. The Athenaeum: The Clerk had been informed that insurance cover had not yet been obtained but that a guarantee was available from the intended supplier. The talk given by John Chew on 13 April on memories of his time at the Blue Bell had been very successful
