155/24 Apologies: None

156/24 Minutes: It was **resolved** that the minutes of the meeting held on 30 October 2024 be confirmed as a true record and be signed by the Chair

157/24 Declarations of Interest: Cllr. Grindey declared an interest with regard to item 166/24c re Martin Tyson and item 166/24d

160/24 Ongoing Items

- Extension of 50mph limit to Levens: A consultation was ongoing. The Council fully supports the proposal
- Crow Wood: No reply had yet been received regarding clarification of the ownership of the area used for parking
- Yellow line parking restrictions: A consultation was ongoing. The Council **agreed** to comment that it has always been the Council's request to close the northern gap in the yellow lines near the playground entrance; that the southern gap (near Crow Wood) should remain open; that the yellow lines should be extended from the playground to opposite the entrance to Plumtree Hall; and that the other yellow line restrictions should remain unaltered. The Council doesn't agree with the extension opposite the church and is strongly of the opinion that the gap between the bus stop and the start of the yellow line opposite the church should remain as at present
- Field of Dreams: A reply to the Council's claim was still awaited

161/24 Reports

- a. Westmorland & Furness Cllr. Battye referred to the ward boundary submission by W&FC to the Boundary Commission for review. The submission included this parish being part of a 2 councillor ward from May 2027. She also referred to the polling district and waste collection items in Correspondence (167/24); National Highways having no finance for the requested roundabout at Gilpin Bridge and the current proposal for speed cameras on the A590; the street lighting proposals on which the Clerk had commented as to their unfairness to Heversham parishioners; and to the 20mph zones moving forward so that it could be known early in the new year whether Heversham will be on the next list
- b. The Athenaeum: Cllr. Grindey reported that the Antarctica talk had been a success but that the tanking of the snooker room appeared to have failed
